

Joplin VAR Recounts How Tornado Uprooted Town, Life

The tornado sirens had gone off before. Lots of times. Their piercing wail is just a part of life in Missouri as well as other parts of the Midwest known as Tornado Alley. But this time, Jane Cage, COO of Heartland Technology Solutions, a Joplin, Mo.-based VAR, had a more ominous feeling as she put her cat in a carrier and her dogs on leashes, grabbed her cell phone, wallet and flashlight and headed to the basement.

"We stayed down there 30 minutes. All I could hear is hail and wind blowing. I couldn't really see anything," Cage said. When she emerged she was relieved to find her house was relatively unscathed and she thought it was just another false alarm.

"It didn't look too bad. We knew a tornado had come through. We had no TV so we didn't realize how bad things were. Then as the evening wore on you start to hear that the high school was destroyed, that Home Depot was gone. In some cases you couldn't tell what was rumor or fact, but then we began to realize how bad it was," she said.

Cage was one of the lucky ones. The storm and tornadoes that passed through Joplin killed more than 120 people, destroyed scores of buildings and ripped a hole into the fabric of the lives of this close-knit community of 50,000.

Almost immediately, Cage and others set out to help those in need. She tried to get to the house of a friend, but soon realized it was an impossible task.

"We had to go one block over and four blocks north but we couldn't even get there, there was so much debris and power lines. We couldn't even tell where we were. We had no idea what street we were even on," Cage said. "How could that be when I've lived here for 30 years and I can't figure out where I am in town?

"There's no landmark left to let you know where you are. All I could think was, 'Let's get out of here.' It almost felt like a place you couldn't be."

In the three days since the tornado struck, Cage said she's been touched by the overwhelming number of calls, e-mails and text messages she's received from friends in the IT industry and hasn't had time to personally reply to everyone.

Cage's office suffered little damage, but many of her customers, co-workers and friends were not so lucky.

"Looking at pictures of it is one thing. That's just flat. Standing in middle of it gives you a completely different view. When you stand and as far as you can see there's nothing but tree trunks and debris, it's terrible. It's just overwhelming," Cage said.

Cage said it's hard to not feel some guilt for sustaining relatively little damage when others have suffered so much more.

Next: Striking So Close To Home

"Our dispatcher, her mom's house was completely destroyed. We're all torn between the business of the day and how to figure out how to help people and what to do," Cage said. "It almost feels like it's too early to get past anything but the basics right now. Everybody has a place to stay, transportation, clothes. Those are the things everyone is trying to solve right now."

As of today, most people haven't started thinking about getting back to business, Cage said. "The problem is we're still in such a destructive phase. There's no time to rebuild yet. We're still picking through to try to salvage," Cage said.

Cage has been on mission trips in the past, including one to Greensburg, Kans., a year after a deadly tornado struck, to help relief efforts there. Like many people, she never thought a similar tragedy would strike so close to home.

"We just completed our business continuity plan about a week ago, where to meet if our office was destroyed and all of that. But from a personal perspective, you always go somewhere else to help. I never thought we'd be in a position to have people need to help us. It never occurs to you that YOU will be the place," Cage said. "I felt really bad about the people of Greensburg, Kansas. Now anytime I go anywhere now and tell people I'm from Joplin, they'll say, oh, that's where that bad tornado was."

Donations, Fast Action Help Joplin VARs Get Customers Back Online

Donations from the IT industry are pouring into Joplin, Mo., to help VARs and businesses hit by the tornado that tore through the city May 22.

Heartland Technology Solutions, a Joplin-based VAR, on Friday delivered a Mitel 5000 phone system and 12 handsets, donated by Mitel, to the Joplin Family YMCA, which had announced the previous day that it would offer free day care to families impacted by the tornado.

Home Depot donated \$100,000 to the YMCA to help run the program but the YMCA has struggled to meet the demand of people calling in with requests for child care. More than 300 signed up the first day and the demand is expected to increase, said Cookie Estrada, CEO and executive director at the Joplin Family YMCA.

The new phones will be a huge help for families trying to get through to give kids something to do while the sort through all the damage, Estrada said.

Heartland executives told Estrada Friday morning of the incoming system.

"Will that help?" asked Jane Cage, Heartland's COO.

"Wow, you don't know how much. I don't know if you understand the scope of why that's so important, but thank you," said Estrada to Heartland executives Cage, Arlin Sorensen and Larry Hedin.

Hewlett-Packard also donated a <u>server</u> for Heartland to install at the YMCA too. The Joplin YMCA is also taking donations through www.joplinfamilyy.org.

Meanwhile, Heartland is also expecting a large shipment of servers, laptops, switches and printers to give to the community.

HP and other vendors, including Cisco Systems, Dell and APC also made sure quick deliveries arrived for SNC Squared, a Joplin, Mo.-based VAR that had its office right in the path of the tornado. Its office was obliterated and employees are now working out of the home of CEO John Motazedi. "We have a mix of customers that are completely gone and some not at all," Motazedi said.

Five Business Hours After Tornado, Joplin VAR Back Online

John Motazedi is standing on a large pile of rubble, looking for anything recognizable or salvageable in the wood and concrete and God knows what else that used to be the headquarters of SNC Squared, the Joplin, Mo.-based solution provider business he's owned since 2007.

It's been five days since a Class EF5 tornado carved a one-mile-wide by five-mile-long path of destruction on May 21, destroying an estimated 30 percent of Joplin, an estimated 8,000 buildings, 300 businesses and at least 140 lives. Looking over the debris that was his office building, Motazedi points to where his desk used to be. Nearby is a commode and a package of unopened toilet paper fairly close to where the bathroom used to be. But the desk? Nowhere in sight (click here for video of Motazedi surveying the damage).

He steps carefully to the top of the pile, up a collapsed concrete wall, which offers a 360-degree view of about a mile in any direction. Total devastation as far as the eye can see. Less than a mile to the west is St. John's Regional Medical Center, or at least the ghost of St. John's. The tornado shifted the entire nine-story building four inches off its foundation. It moved a whole hospital.

The St. John's building has become an iconic symbol here for the destruction that Mother Nature can cause. What once served as a vital element in this close-knit community of 50,000 in Southwest Missouri is now just a lonely shell with blown-out windows eerily exposing its devastated innards.

"We could never see the hospital from here before. This area was so green and there were so many buildings," Motazedi recalls from SNC Squared's address. Now they're all gone. Many of those buildings housed doctor's offices and other health-care businesses, conveniently situated near the hospital. Many of those businesses were Motazedi's clients. They were part of the reason he picked this spot for SNC Squared's headquarters.

Of course, all that's changed now. The tornado, which occurred at 5:41 p.m. on Sunday, May 21, destroyed SNC's office, as well as everything else around it. Motazedi was still looking for a new office on May 31, as were some of his physician customers. Almost one-third of SNC Squared's 75 health-care customers were impacted by the tornado.

"We liked to be near our clients. The problem is everyone was around the hospitals. Now there is no [St. John's] hospital," Motazedi said.

One customer closed his shop to take employment at another facility, and a second customer is leaving town for good. Four of his five largest customers sustained tornado damage, and about 460 of the 970 workstations that he manages as an MSP went down, he said.

Yet, incredibly, Motazedi was back online himself by 2 p.m. Monday. After picking up the shambles of his own business first, he turned his attention to the clients that needed him most. He had 100 percent of his clients' networks back online by 5 p.m. on Thursday, May 25, thanks to some quick action, flexible suppliers, patient customers and a lot of help from some solution provider peers both near and far. Here's how he did it:

Next: Disaster Strikes

The tornado sirens were sounding and the weather seemed to worsen. Quickly. It was Sunday night, just after 5 p.m. and Motazedi gathered his wife and three kids and headed to the family's basement in a wooded residential neighborhood of Joplin. The family stayed in the basement about 30 minutes, during which time they lost power but sustained almost no damage to their home.

But Motazedi was worried about SNC Squared's office because he knew that the magnetic doors would only remain locked for another hour or two on battery power if the lights were out in that part of town a couple miles away.

Motazedi grabbed the keys to the building and with his family in tow started to drive to the office. They had not gone far before realizing that a tornado had indeed struck Joplin and decimated whole neighborhoods.

"We just saw this massive chaos. I'm trying to weave my way through it. The kids are screaming and crying. My wife is saying, 'I can't believe this,' " Motazedi said.

The Motazedis spotted a couple with four small children, including an infant covered by wet towels, walking in the general direction of a hospital. Motazedi pulled over and packed the family, who were in a daze, freezing cold and suffering from multiple lacerations, into his car and drove them to Freeman Health System Hospital nearby.

At Freeman, Motazedi saw a familiar pediatrician and asked if she needed help. The doctor said she was shuttling supplies to Freeman from St. John's, which had been heavily damaged by the tornado. Motazedi left his family at Freeman and got back in his car, following the pediatrician back to St. John's.

"The building was completely destroyed. It literally looked like a bomb went off. But we climbed through the debris and got gloves, peroxide, stitches, Band-Aids, anything we could dig out," Motazedi said. He made multiple trips back and forth before St. John's security said the building was not structurally sound and shut down access.

Back at Freeman, Motazedi gathered his family and headed home to put the kids to bed. He had gotten a text from one of his techs that the office was a wreck. About 11:30 p.m., he found a tarp and drove to the office to check out the damage. Or he tried to, at least. Debris and downed power lines in the road prohibited vehicle access, so Motazedi had to hoof it in the dark. He thought he was in the right spot, but the total devastation made finding a landmark impossible, he said.

"I got to the street and said, 'I wonder where my building is.' I turned around and saw the L-shaped parking lot and realized that this was actually my parking lot. I looked over [where the building should be] and I realized, 'That's my business.' It was kind of like, 'Wow, there's nothing left. I hope our backups are good,' " Motazedi said. "[There] was actually a sense of relief. I knew we didn't have any techs working over here. I had immediately texted all my techs and they all had responded that they were fine. So no one we knew was injured [nor] their immediate family. That was a relief. All this stuff can be replaced. This is insignificant."

Next: Salvage Mission

In the dark, Motazedi found his server rack, which had "accordioned" down with the weight of the fallen building. He put a tarp over the server rack because up to two more inches of rain were expected later that night.

Meanwhile, a nearby search and rescue team saw Motazedi, who had a flashlight, and summoned him over. They said there might still be bodies in some buildings to the south. "Luckily, we didn't find anything," Motazedi said. "I went home about 1:30 but didn't sleep at all. At 5 a.m. I just got up."

He went back to the remnants of SNC Squared's office and started to pull out any equipment and supplies that could be salvaged.

"When I got there I saw the [server] rack; a wall had fallen on it but it seemed dry because of the tarp. We needed Sawzalls and wire cutters to get the stuff out. We poured water out of a couple of them. We got them to my house and opened them up, blew them out and dried them off. I found a network switch, said some Hail Marys and turned them on," Motazedi said.

Almost miraculously, many of the servers fired up, although some firewalls and switches had to go in the trash can. He made a list of equipment he still needed to create a temporary NOC in his basement and had employees hit every store within a 40-mile radius to retrieve the items.

"We had some spare firewalls at my house. We did the routing. We worked with three different companies: Zenith [Infotech], Datto and eFolder. All of them were phenomenal," said Motazedi. "We had to get power from every outlet in the house. We have extension cords coming in through windows, from the garage, from upstairs to power all this stuff. We actually had 21 servers at one point running [in the basement]."

At 2 p.m. Monday, clients were back up on all three solutions, he said, only five business hours after the tornado struck the night before.

If the servers had failed, Motazedi said he could have had replacements within 24 hours, but he was proud of the fact that he had customers online the first business day.

SNC Squared had a "pseudo [disaster recovery] plan," Motazedi said. "It came out of a plan for what happens if an employee goes rogue. What key things do you need to protect? That included passwords and access to servers. Then, do you have all the vendor information you need and so you need to secure any portals?"

Motazedi credits help from other VARs in his Heartland Tech Groups chapter, including at least two who traveled from Minnesota and Arkansas to provide on-the-ground support. Executives from another Joplin VAR, Heartland Technology Solutions, as well as Network Data Services in Little Rock, Ark., and Success Computing in Minneapolis joined SNC employees on salvage missions from customer locations.

"We were <u>hosting</u> clients' servers in our NOC at 2 p.m. Monday. The remainder of the day, we started contacting every one of our clients to say, 'We're showing you down in LabTech and wanted to confirm that you are down.' We put together a list of our managed services clients and put them in priority followed by our break/fix clients," Motazedi said.

Next: Back In Business

Teams went to each location to salvage equipment and take inventory. They brought whatever equipment they could find to Motazedi's basement, now turned into a NOC. Techs also contacted Zenith Infotech, eFolder and Datto to get the last image backed up to the cloud.

"Luckily, most of them didn't see patients that Sunday so they all had valid data good as of Friday night or Saturday morning," Motazedi said. "The problem we were running into is they needed the patient information. Their server was up, but they had no way to access it. We had clients coming to my basement, logging onto their server. We provided printers and scanners so they could print out reports and their schedule of patients."

Meanwhile, SNC Squared was ordering laptops, UPSes and other equipment, knowing that customers were going to need new products to resume business.

Craig Hillyard, CEO of Network Data Services, one of Motazedi's peers from Heartland Tech Groups, arrived Monday to help with that task. "We came to the decision that if we don't order it now, when are we going to get it in? It took us three days to get the equipment in so now when people have [new] offices we've got the ability to get them back up and put equipment in their office today, whereas a lot of other people are just saying, "Well, what do we need?" "Hillyard said, "John's way ahead of the ballgame and he's actually got doctors operational and [they] have the ability to see patients and access the systems. We're on Day 5 of a major tornado wiping out an area. His business is functional and his clients are up and running. It's phenomenal."

Motazedi is understandably proud of the fact his business was back only five business hours after his office was demolished. He cautioned other VARs to make sure they would be able to do the same if disaster strikes. Before you can help your clients, he said, the first step is to make sure your own business is back first.

"Can you come up in five hours? If you can't or don't have a plan, you can't help your customers. There's no way. If you've got a house in shambles, chaos in your business or your business doesn't even exist, you can't help anybody," Motazedi said. "You need a good strategy in place in terms of what's going to actually happen, how are you going to roll it out and then practice it."



Disaster *Recovery*: The Most Critical Part To Data Backups That Most Companies Overlook

A few months back tornados ripped through both Joplin, MO and Tuscaloosa, Alabama causing massive devastation. If you were fortunate, you only had to

suffer through minor interruptions of utility services, with others paying a far steeper price. This got me thinking about how important disaster recovery planning is to any business. No one expects terrible things to happen, but when they do, having that plan in place can really save your bacon. And one of the



MOST important aspects of this is the *recovery* part – how are you going to get that data back onto a working platform that allows you to continue serving your customers and operating your business. <u>The shocker for most business owners is that simply having a copy of the data does NOT guarantee a fast recovery</u>. Let me give you an analogy to help you understand...

Let's suppose we put a disaster recovery plan in your home. Your house would represent the server and platform, and all your furniture and personal items would be the data. Now let's suppose we could make a backup of your home by making an exact copy of everything that's in your house (all your furniture, appliances, clothing, etc.) and storing it in a "backup" shed. Then the unthinkable happens: your house gets leveled by a tornado, flood or fire and everything is gone (or a critical part of it is damaged and needs to be replaced). You would think, "Well, at least I have a copy!" True, but the first thing you would need to do is replace the home itself (remember, that's the platform that everything resides on). Next you would have to "reinstall" the services like gas, electricity and water (let's call that the software). Then you would have to haul everything from the shed back to the house and "reformat" it by arranging it into the house. Depending on the extent of the damage done to your house, that could take days or weeks; chances are you'd have to find a hotel to live out of in the meantime. In addition, there's the time and cost of moving everything back in and re-arranging and restoring everything to its proper place.

Plus, the above *assumes* you have a recent, working copy of your entire home and everything in it. If you failed to make a copy – or if the shed where you were storing everything had a water leak that destroyed everything inside due to mold – then you're really out of luck.

Of course, this is a simple analogy – and there are ways to back up your data and network so that recovery can happen inexpensively in a matter of hours versus days or weeks. But if you simply think having a tape backup is...

The Top 5 Long-Life, Lightweight Laptops For Business Travelers

If you travel a lot and you're tired of anemic laptop batteries that make you hunt down a power outlet in the airport, you'll want to know about these new portables that can sustain you from LAX to New York. The four netbooks and four notebooks, arranged in order from longest to shortest battery life, will keep you going for anywhere from 6 and a half hours to nearly 9 hours. With battery power like that, you'll be able to keep your attention on your work and be very productive on the road.



Lenovo ThinkPad X200

This lightweight laptop offers maximum battery life of 8 hours and 54 minutes when tested with a nine-cell battery option. The battery adds less than a pound to the computer, bringing the total weight to only 3.7 pounds for easy carrying. The nine-cell battery upgrade costs only \$50 more. The price for this laptop is currently around \$951.

Samsung N110

The Samsung N110 did a stellar job in PC World's battery tests, lasting 8 hours, 23 minutes on a charge. At 2.7 pounds, this netbook is easy to carry as well. Prices for this model have dropped, putting it around \$410.

Lenovo ThinkPad T400

ThinkPads are catnip to business travelers, thanks to their sturdy construction, solid performance, roomy keyboards, and – in the case of the Lenovo ThinkPad T400 – excellent battery life. The nine-cell battery added a bit of bulk but kept us working just shy of 8 hours. The T400 is available online for \$1289 and up.

Acer TravelMate 6293

The Acer TravelMate may look a bit drab, but when it comes to long batter life, this one is a winner. In tests, it lasted 7 hours, 57 minutes; and for \$999, the price is right too.

Samsung N120

This netbook not only has a great battery life but it also offers a very comfortable keyboard. In PCW tests, the N120 went for 7 hours, 43 minutes on a charge, which is excellent but not quite as good as its netbook sibling, the Samsung N110. The N120 is priced around \$410 online.

Steve Jobs Is Building A Spaceship On Earth

(Cupertino City, CA To Be Exact)

Steve Jobs is "selling" Apple again – only this time he's pitching the Cupertino City Council on allowing him to develop a 150-acre plot of land to build, "The best office building in the world." This building will be home to a new Apple Campus – and without a doubt it's a very ambitious plan.

This giant building would hold 12,000 people. But that's not what makes this project so interesting — it's the circular design that gives it a spaceship appearance. In fact, there won't be a single straight piece of glass on the outside.

During his presentation, it was reported that Steve Jobs wasn't in his normal "pitch mode" we're used to seeing on stage at Apple keynotes and events. During this presentation he was reported as being much more low-key because he knows the city council can say "No" to his project if they want to. He's still salesy, but doesn't use words like "magical" or "insanely great."

And yet you can still see a tough streak in his proposal. When a council member asked if Apple plans to give the city free Wi-Fi, he replied, "We're the largest taxpayers in Cupertino, so we'd like to continue to stay here and pay taxes." Obviously that can be both a benefit and threat that Apple would pack up its bags and leave if not granted this request. Other highlights about the campus:

- The building would use its own natural gas generator as its primary source of power and the city's power grid only as a backup.
- The building includes an auditorium for conferences giving them the ability to hold their events there instead of San Fran.
- Apple wants to break ground next year, and move in by 2015.

Groupon:Good Idea Or Invitation To Price Shoppers?

Groupon, launched in November 2008 in Chicago, is a highly successful online marketing venue for businesses looking to gain more customers and for consumers looking for great deals on things they already buy. Here's how it works: Businesses wanting to reach more customers sign up for a "daily deal" promotion where they offer some product or service at half off the normal costs. Groupon then sends that offer out to a list of users who have signed up to receive these daily deals. But here's the "catch" (or the brilliance depending on how you look at it): in order for the deal to be "on," a certain number of people must buy the deal — otherwise it's off.

What this does is fuels people who WANT the deal to pass it on to friends and family to try and pump up the offer so they can get in on it. In doing so, Groupon naturally gets more users to sign up for their daily deal and keeps a hefty percentage of the sale. Also, the deal is only good for that day, building in an automatic urgency to buy. Clearly this is a good deal for consumers who get to buy products and services at deep discounts — but is it a good deal for the businesses that are using this as an advertising media?

Some say yes because it allows a new startup business to gain actual buyers to their store or web site at a break even or loss. And if you are providing a service that people really like, chances are they'll come back and tell their friends. However, some say it only attracts price shoppers who have zero loyalty; and no business wants that type of customer, especially when you have to deliver the products and services at a break even or loss. So how do you find out whether or not it will work for you? The best idea is to run a test and track the results. Obviously if you offer a great service that begs repeat business, it makes sense to advertise using Groupon because the upfront loss will be more than made up from in long-term repeat business and referrals. But if you have a problem with customer retention and loyalty, Groupon might not be the best place for you to advertise.
